#### Roland Bent Joins Supervisory Board of SMA Solar Technology AG

Niestetal, February 3, 2015–On January 28, 2015, the Kassel District Court appointed Roland Bent, a member of the management of Phoenix Contact GmbH & Co. Since 2010 he has been a guest professor at Tongji University in Shanghai.

The SMA Supervisory Board will elect a new chairman at its meeting on February 11, 2015.
